IMPLEMENTATION OF PMKSY

100. DR. KALPANA SAINI:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) the progress achieved regarding implementation of Pradhan Mantri Kisan Sampada Yojana (PMKSY), State-wise, with respect to the various components of the Scheme which includes the number of projects sanctioned, projects completed and resultant processing for the last three years; and
- (b) the details of preservation potential, allocation of funds for each component and number of employment opportunities generated?

ANSWER

(a). The Ministry of Food Processing Industries (MoFPI) has been implementing an umbrella scheme - Pradhan Mantri Kisan Sampada Yojana (PMKSY) - since 2017-18 across the country. PMKSY is a comprehensive package of component schemes, which is aimed at creation of modern infrastructure with efficient supply chain management from farm gate to retail outlet. It provides a boost to the growth of food processing sector in the country, helps in providing better prices to farmers, creates employment opportunities especially in the rural areas, reduces wastage of agricultural produce, increases the processing level and enhances export of the processed foods. Under various component schemes of PMKSY, financial support in the form of grants-in-aid is provided for setting up of food processing projects across the country.

Under PMKSY, the number of project sanctioned, project completed and resultant processing and preservation capacity for the last three years i.e. 2020-21, 2021-22, 2022-23 and 2023-24 (till date) may be seen at **Annexure-I**.

(b). The details of allocation of funds for each component of PMKSY and number of employment generated for the last three years i.e. 2020-21, 2021-22, 2022-23 and 2023-24 (till date) may be seen at **Annexure-II**.
