**Implementation of Green India Mission in Punjab**

674 SHRI VIKRAMJIT SINGH SAHNEY:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the projects implemented or ongoing under Green India Mission (GIM) in the State of Punjab;
- (b) the details of the funds allocated, released and utilized, State-wise under GIM including Punjab in last five years, year-wise, State-wise and project-wise;
- (c) steps taken by Government for afforestation, increasing forest cover and to deal with climate change in the State of Punjab; and
- (d) funds allocated and funds released by the Ministry on various schemes in the State of Punjab?

- (a) & (b) National Mission for a Green India (GIM) is one of the eight Missions outlined under the National Action Plan on Climate Change. It aims at protecting, restoring, and enhancing India's forest cover and responding to Climate Change by undertaking plantation activities in the forest and non-forest areas. GIM activities were started in FY 2015-16. The details of the funds allocated/released and utilized, State-wise under GIM including Punjab in last five years is given in **Annexure-1**.
- (c) & (d) The Ministry of Environment, Forest and Climate Change encourages and provides continuous support to the State of Punjab through various schemes/programs such as the National Mission for Green India (GIM), Nagar Van Yojana, Compensatory Afforestation Fund Management and Planning Authority (CAMPA) funds, Forest Fire Prevention and Management (FFPM) and Environment Education Programme for afforestation activities, increasing forest cover and to deal with Climate Change. The funds allocated/released by the Ministry under various schemes in the State of Punjab during the last five years are given in **Annexure-2**.
