WOMAN BENEFICIARIES UNDER PM-KISAN

16. SHRI NEERAJ SHEKHAR:

Will the Minister of Agriculture and Farmers Welfare be pleased to state:

- (a) the number of Pradhan Mantri Kisan Samman Nidhi Yojana (PM-KISAN) beneficiaries in the country as on date, State-wise; and
- (b) the number of woman beneficiaries out of the above, State-wise?

ANSWER

(SHRI ARJUN MUNDA)

- (a) The PM-KISAN scheme is a central sector scheme launched in February 2019 to supplement the financial needs of land-holding farmers. Under this scheme, the financial benefit of Rs 6,000/- per year in three equal instalments every four months is transferred into the bank accounts of farmers' families across the country through Direct Benefit Transfer (DBT) mode. A farmer-centric digital infrastructure has ensured the benefits of the scheme reach all the farmers across the country without any involvement of the middlemen. As on date, there are more than 8.70 Cr. eligible farmers in the PM-KISAN Scheme. The State-wise breakup of the same is at Annexure-1.
- (b) The State-wise number of eligible women beneficiaries as on date under Pradhan Mantri Kisan Samman Nidhi Yojana (PM-KISAN) is attached at Annexure-2.
