TOILETS AND HOUSES UNDER PMAY (G) & SBM (G)

593 SHRI ANEEL PRASAD HEGDE:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the total number of houses and toilets sanctioned and completed under PMAY(G) and SBM (G) for last 5 year, State/UT-wise details;
- (b) whether Government maintains data of PMAY (G) beneficiaries according to social and religious groups they belong to;
- (c) if so, the details of total number of houses sanctioned and completed and total number of beneficiaries who belong to SC, ST & Minority community year-wise, catagory-wise for last 5 year under PMAY (G) & SBM (G) till date, State/UT-wise; and
- (d) if not, the reasons for not maintaining category-wise data?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT
(SADHVI NIRANJAN JYOTI)

(a): In order to achieve the target of “Housing for All” in rural areas, the Ministry of Rural Development is implementing Pradhan Mantri Awaas Yojana- Gramin (PMAY-G) with effect from 1st April, 2016 to provide assistance to construct 2.95 crore pucca houses with basic amenities by March 2024. Total target of 2.95 crore houses under PMAY-G, has already been allocated to States/Union Territories (UTs), out of which more than 2.94 crore houses have already been sanctioned to the beneficiaries by various States/ UTs and over 2.55 crore houses have been completed as on 03.02.2024.

The PMAY-G focuses on provision of construction of house with basic amenities to the households through convergence with other Government Schemes viz., 90/95 person-days of unskilled labour wage from MGNREGS for construction of house over and above the unit assistance, assistance of toilets through convergence with Swachh Bharat Mission – Gramin (SBM-G), MGNREGS or any other dedicated source of funding, availability of piped drinking water, electricity connection, LPG gas connection, renewable energy source and building material & efficient cooking fuel, treatment of solid and liquid waste, etc.

State-wise details of houses sanctioned by the States/UTs and houses completed during the last five years i.e. financial years 2018-19, 2019-20, 2020-21, 2021-22 & 2022-23 under PMAY-G is given at **Annexure-I**. The details of toilet constructed through convergence since inception of the PMAY-G is given at **Annexure-II**.

State/UT-wise, number of Individual household latrines (IHHLs) constructed under Swachh Bharat Mission-Grameen [SBM(G)] during last 5 years i.e. financial years 2018-19, 2019-20, 2020-21 to 2022-23 is at **Annexure-III**.

(b) to (d): The PMAY-G guidelines provisioned a minimum 60% of the target at the national level which is earmarked for Scheduled Caste (SC)/Schedules Tribes (ST) households subject to availability of such eligible beneficiaries. The earmarking will only define the minimum limit that should be achieved and if State/UTs so desire they may add to target under these categories to ensure saturation. This would be in consonance with the category wise saturation approach which requires beneficiaries belonging to vulnerable and disadvantaged groups to be covered on a priority basis.

The Year-wise/State-wise details of total number of houses sanctioned and completed during last five years i.e. financial years 2018-19 to 2022-23 in respect of SC/ST category under PMAY-G is given in **Annexure-IV**.
