Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the number of the Particularly Vulnerable Tribal Group (PVTG) families, who would be covered under the Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JANMAN) State-wise; and
- (b) the number of Interventions to be taken under PM-JANMAN, Ministry-wise?

ANSWER

(a): Pradhan Mantri Janjati Adivasi Nyaya Maha AbhiyaN (PM-JANMAN) aims to cover 75 PVTG communities residing in 18 States and UTs. The Ministry of Tribal Affairs through the State Governments / UT Administration/departments have undertaken habitation level data collection exercise through PM Gati Shakti mobile application to estimate PVTG population figures and infrastructure gaps in order to cover PVTG beneficiaries / PVTG villages & habitations under PM-JANMAN Mission. The exact number of PVTG families to be covered is subjected to eligibility criteria of specific guidelines of concerned interventions. As on 31.01.2024, the number of PVTG households as enumerated by the states on the portal, State-wise, are tabulated below:
