### Data base of persons killed in human and animal conflict

692 Shri Samirul Islam:

Will the Minister of ENVIRONMENT, FORESTAND CLIMATE CHANGE be pleased to state:

- (a) whether the Ministry maintains a database of all persons killed/maimed due to human-elephant conflict in a calendar year;
- (b) if so, the number of such persons killed/maimed between the years 2019 to 2023 State/UT-wise;
- (c) whether Government has any mechanism to offer financial relief and jobs to the families of such victims; and
- (d) if so, the number of families who have received relief from the Ministry between 2019-2023, State and UT-wise?

#### **ANSWER**

(a)to(d) The State-wise details of human casualties due to elephant attacks, between 2019-20 to 2022-23, as per the information received from States, are enclosed as **Annexure.** In addition to compensation schemes of the State Governments/UTs Administration, the Ministry is also providing financial assistance to States/UTs under Centrally Sponsored Scheme, Project Tiger & Elephant, for ex-gratia relief at the following rates:
