**732. SHRI R. DHARMAR :**

**Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:**

- (a) whether Government is implementing the Atmanirbhar Bharat Rojgar Yojana (ABRY), if so, the details of progress made so far, year-wise within the State of Tamil Nadu;**
- (b) the number of beneficiaries under the ABRY in the State of Tamil Nadu;**
- (c) the details of funds allocated, sanctioned and released under ABRY in the State of Tamil Nadu so far along with the achievement made in providing employment to the youth of the country;**
- (d) whether Government proposes to revise the eligibility conditions under ABRY to make it more beneficial; and**
- (e) if so, the details thereof and the time by when it is likely to be implemented?**

**ANSWER**

**(a) to (e): The Aatmanirbhar Bharat Rojgar Yojana (ABRY) was launched with effect from 1st October, 2020 to incentivize employers for creation of new employment and restoration of loss of employment during Covid-19 pandemic. The terminal date for registration of beneficiaries was 31.03.2022. The beneficiaries registered upto 31.03.2022 will continue to receive the benefits for 2 years from the date of registration under the scheme. There is no specific State-wise allocation of funds under Aatmanirbhar Bharat Rojgar Yojana (ABRY). As on 19.01.2024, total benefits have been provided to 60.49 lakhs beneficiaries under the scheme in the country. The number of benefitted establishments, beneficiary employees and amount disbursed (Rs. In Crore) for the State of Tamil Nadu is given below:**
