**PROMOTION OF TOURISM UNDER SWADESH DARSHAN SCHEME**

771 SHRI BIPLAB KUMAR DEB:

Will the Minister of **TOURISM** be pleased to state:

- (a) the manner in which the Swadesh Darshan Scheme been instrumental in promoting tourism and cultural heritage in India; and
- (b) specific initiatives and projects which have been implemented under this scheme in the State of Tripura to enhance visitor experience and boost local economies?

**ANSWER**

(a) & (b): The Ministry of Tourism launched its Swadesh Darshan Scheme (SDS) in the year 2014-15 with the objective to augment tourism facilities in the country thereby promoting culture and heritage of the country, enhancing tourist attractiveness in a sustainable manner, creating awareness among the local communities about the importance of tourism, creating employment through active involvement of local communities etc.

The Ministry of Tourism has sanctioned 76 projects in the country under identified themes including 10 Heritage theme circuits and 02 projects in Tripura under North East Circuit theme of SDS. The details of these projects are at annexure-I.

The Ministry of Tourism has revamped the Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible tourism destinations, following a destination & tourism-centric approach and have notified 57 destinations in the country for development under SD2.0 including 'Agartala' and 'Unakoti' in Tripura for development under SD2.0. The detail of these notified destinations is at annexure-II.
