STATUS OF FOOD PROCESSING INDUSTRY IN THE COUNTRY

2148. SHRI K.R.N. RAJESHKUMAR:

Will the Minister of ***FOOD PROCESSING INDUSTRIES*** be pleased to state:

- (a) the total number of food processing enterprises in the country, category-wise (large, medium, and micro), State-wise;
- (b) the total number of Self-Help Groups (SHGs) and producer cooperatives involved in food processing, State-wise; and
- (c) the details of ongoing and upcoming projects and initiatives by Government in Tamil Nadu?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES
(SHRI RAVNEET SINGH)

- (a) As per the latest report of Annual Survey of Industries (ASI) for the year 2021-22 conducted by Ministry of Statistics and Programme Implementation (MoSPI), the State-wise information on total number of registered food processing units in the country are placed at **Annexure-I**.
- (b) Under Pradhan Mantri Formalisation of Micro food processing Enterprises (PMFME) Scheme of Ministry of Food Processing Industries (MoFPI), seed capital support is provided @ Rs. 40,000/- per member of Self Help Groups (SHGs) engaged in food processing for working capital and purchase of small tools subject to maximum of Rs. 4 lakhs per SHG Federation. As on 30th June 2024, 1,34,468 SHGs involved in food processing have been sanctioned for assistance with Seed Capital. Under Credit Linked Subsidy, 27 loans for Producer Cooperatives have been sanctioned by the lending banks for setting up of food processing units. The State-wise details are at **Annexure-II**.
- (c) As on 30th June, 2024, the details of the projects in the state of Tamil Nadu under various schemes of Ministry of Food Processing Industries (MoFPI) are as below:
 - i. Under various components of Pradhan Mantri Kisan SAMPADA Yojana (PMKSY), a total of 148 projects have been approved and out of these 100 projects have been completed.
 - ii. Under Pradhan Mantri Formalization of Micro food processing Enterprises scheme (PMFME) of MoFPI, assistance have been provided to 12,220 micro enterprises with subsidy of Rs.247.36 Crores.
 - iii. Under Production Linked Incentive Scheme (PLIS) for Food Processing Industry, 20 units are in the State of Tamil Nadu.
