- (b) the details of the number of beneficiaries of this Yojana, State-wise and sector-wise; and**
- (c) the details of the total amount spent from the budget allocated for this Yojana?**

**ANSWER**

**(a) to (c): The Aatmanirbhar Bharat Rojgar Yojana (ABRY) was launched with effect from 1st October, 2020 to incentivize employers for creation of new employment and restoration of loss of employment during Covid-19 pandemic.**

**The salient features of the scheme are summarized below:**

- An employee drawing monthly wage of less than Rs. 15000/- who was not working in any establishment registered with the Employees' Provident Fund Organization (EPFO) before 1st October, 2020 was eligible for the benefit. The employees who lost their job during Covid-19 pandemic and did not join in any EPF covered establishment upto 30.09.2020 were also eligible for the benefit.**
- Government of India for a period of two years, credited both the employee' share (12% of wages) and employer's share (12% of wages) of contribution payable or only the employee's share, depending on employment strength of the EPFO registered establishments.**
- The scheme commenced from 1st October 2020 and registration was open for eligible employers and new employees upto 31.03.2022. The beneficiaries registered upto 31.03.2022 continued to receive the benefits for 2 years from the date of registration under the scheme.**

**As on 31.03.2024, an amount of Rs. 10,188.50 crore has been disbursed to 60.49 lakh beneficiaries.**
