IN-SITU REHABILITATION OF SLUM DWELLERS UNDER PM AWAS YOJANA-URBAN (PMAY-U)

65. SHRI AJAY MAKAN

Will the Minister of Housing and Urban Affairs be pleased to state:

- (a) the details of year-wise break-up of each of the 4 components (since the inception of the scheme), i.e., PMAY-U has four components: in-situ rehabilitation of existing slum dwellers, credit-linked subsidy scheme (CLSS) for EWS, affordable housing in partnership (AHP), and subsidy for beneficiary-led individual house construction, in terms of allocation by the Ministry, resources transferred by the Ministry, number of houses sanctioned and number of houses completed under the scheme;
- (b) the State-wise list of existing houses demolished/grounded, but not completed, along with the period since grounded; and
- (c) the reasons for the above?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING & URBAN AFFAIRS (SHRI TOKHAN SAHU)

(a) to (c): 'Land' and 'Colonisation' are State subjects. Therefore, schemes related to housing for their citizens are implemented by States/Union Territories (UTs). However, Ministry of Housing and Urban Affairs (MoHUA) supplements the efforts of States/UTs by providing Central Assistance under Pradhan Mantri Awas Yojana – Urban (PMAY-U) since June 25, 2015 to provide pucca house in urban areas across the country. The scheme is implemented through four verticals, i.e., Beneficiary Led Construction (BLC), Affordable Housing in Partnership (AHP), In-Situ Slum Redevelopment (ISSR) and Credit Linked Subsidy Scheme (CLSS). As on 15.07.2024, 118.64 lakh houses have been sanctioned by the Ministry, out of which 114.33 lakh have been grounded and 85.04 lakh have been completed/delivered to the beneficiaries and remaining are at various stage of construction. The Vertical wise and year wise Central Assistance sanctioned and released along with houses sanctioned and completed since inception under PMAY-U is placed at Annexure-I.

The period of PMAY-U has been extended till 31st December 2024 for completion of already sanctioned houses till 31.03.2022. Moreover, States/ UTs have been advised to accelerate the pace of construction and ensure completion of sanctioned houses/projects within the stipulated timelines as per Detailed Project Report (DPR). The Ministry conducts regular meetings to monitor progress of the Scheme and completion of houses approved under the Scheme. The State/UT-wise details of houses sanctioned, grounded and completed under PMAY-U are at Annexure II.
