REVIEW OF SMART CITIES MISSION

72. SHRI G.C. CHANDRASHEKHAR

WILL THE MINISTER OF HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the percentage of total projects completed under the Smart Cities Mission;
- (b) the rate of completion/execution for first track cities and round 4 cities;
- (c) whether any review has been conducted on the pace of execution of the project and if so, the details thereof; and
- (d) the proportion of Government contribution to the costs of completed projects as compared to other sources?

ANSWER

- (a) As per the data provided by 100 smart cities, work orders have been issued in 8,016 projects worth ₹ 1,64,223 crore, of which 7,218 projects (90%) worth ₹ 145,083 crore have been completed till 12 July, 2024.
- (b) Status of completion of projects under fast track (FT) and round 4 cities are enclosed as Annexure.
- (c) Smart Cities Mission (SCM) is regularly reviewed at multiple levels. At the city level it is reviewed and monitored by Smart City Advisory Forums (SCAFs) comprising of District Collector, MP(s), MLA(s), Mayor, CEO of SPV, local youths, technical experts etc. At the State level, a State level High Powered Steering Committee (HPSC) chaired by the Chief Secretary reviews Mission implementation, and at the national level, implementation of SCM is being monitored by an Apex Committee headed by Secretary, Ministry of Housing and Urban Affairs (MoHUA). In addition, Mission Secretariat of SCM in MoHUA regularly reviews the status of projects with respective Smart Cities through meetings, workshops, seminars etc.
- (d) As per SCM Guidelines, there is a budgetary provision of ₹ 48,000 crore as Central Government share for 100 Smart Cities out of which Rs. 46,676 crore has been released (97%). An amount of Rs. 40,113 crore has been contributed by the State Government/Union Territory/Urban Local Body (ULB) as on 12 July, 2024.
