STATUS OF PRADHAN MANTRI AWAS YOJANA - URBAN

77. DR. BHIM SINGH

Will the Minister of Housing and Urban Affairs be pleased to state:

- (a) the total number of houses constructed in urban areas under the Pradhan Mantri Awas Yojana-Urban (PMAY-U) so far;
- (b) the number of houses yet to be constructed, acquired or purchased under PMAY-U in the State of Bihar, the district-wise details thereof;
- (c) the total number of beneficiaries under PMAY-Urban from Haryana particularly in Sonapat; and
- (d) whether expansion of PMAY-U has been planned to provide housing in urban areas in future, the details thereof?

ANSWER

(SHRI TOKHAN SAHU)

(a) to (c) 'Land' and 'Colonization' are State subjects. Therefore, schemes related to housing for their citizens are implemented by States/Union Territories (UTs). However, Ministry of Housing and Urban Affairs supplements the efforts of States/UTs by providing Central assistance under Pradhan Mantri Awas Yojana- Urban (PMAY-U) since 25.06.2015 to provide pucca houses in urban areas across the country.

Based on the project proposals submitted by States/ UTs, as on 15.07.2024, 118.64 lakh houses have been sanctioned under PMAY-U, out of which 114.33 lakh have been grounded for construction; of which 85.04 lakh have been completed/delivered to beneficiaries. The State of Haryana has been sanctioned 1,15,034 houses under PMAY-U including 5,371 houses in Sonapat district. The State of Bihar has been sanctioned 3,14,477 houses under the scheme. Of the sanctioned houses; 1,47,979 have been completed and remaining 1,66,498 houses are at various stages of construction. District-wise details of houses sanctioned, grounded for construction and completed under PMAY-U in the State of Bihar are at Annexure.

The scheme period, which was earlier upto 31.03.2022, has been extended upto 31.12.2024, except Credit Linked Subsidy Scheme (CLSS) vertical of the scheme, to complete all the houses sanctioned without changing the funding pattern and implementation methodology. Accordingly, States/UTs have been advised to expedite to complete all sanctioned houses within the extended Mission period as per Detailed Project Reports.

(d) To meet the increased housing demand which is dynamic in nature, the Government of India has resolved to provide assistance to 3 crore additional rural and urban households for the construction of houses.
