(b) to (d): The Ministry of Tourism under its 'Swadesh Darshan', 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies' schemes provides financial assistance to the State Governments/Union Territory Administrations/Central Agencies including Gujarat for development of tourism infrastructure. The Ministry of Tourism has now revamped its Swadesh Darshan scheme in the form of Swadesh Darshan 2.0 with the mission to create a robust framework for integrated development of tourism destinations in partnership with the States/UTs and local governments for promoting sustainable and responsible tourism in the country.
