DAMAGES TO AIRPORT INFRASTRUCTURE

658. SHRI RAJEEV SHUKLA

Will the Minister of CIVIL AVIATION be pleased to state:-

- (a) whether Government is aware of damages to airport infrastructure and collapse of several facilities due to rain this year;**
- (b) if so, the details thereof, including the number and name of such airports and facilities that have been affected;**
- (c) the details of funds spent on maintenance of airports during the last three years, year-wise and airport-wise, details thereof; and**
- (d) the steps taken by Government for proper maintenance and upkeeping of airport infrastructure?**

ANSWER

(a) & (b) During heavy rain, forecourt canopy collapsed at Terminal 1D of Indira Gandhi International Airport, Delhi on 28.06.2024. Also, kerb area Canopy made of tensile fabric, a non-structural element tore at Jabalpur & Rajkot Airports on 27.06.2024 and 29.06.2024, respectively.

(c) The details of funds spent on maintenance of airports during the last three years, year-wise and airport-wise are placed at Annexure-I.

With regard to PPP/JVC Airports, costs related to maintenance and safety audits are an integral part of the overall cost on Operations and Management.

(d) The Safety & Maintenance Standards are being followed as per the industry practice and relevant safety standards. Building safety is also in built during design and construction stage as per National Building Codes. There are routine maintenance checks including proper annual pre-monsoon checks which are adopted. In addition to this, Directorate General of Civil Aviation (DGCA) conducts inspections of licensed airports for airside infrastructure as per its Annual Surveillance Plan and compliance with standards is verified in accordance with DGCA Civil Aviation Requirements Section 4 Series B Part I and International Civil Aviation Organisation (ICAO) Annex 14 Volume I.
