850. SHRI ADITYA PRASAD:

Will the Minister of Corporate Affairs be pleased to state:

(a) the number of Central Public Sector Undertakings (CPSUs) of the Central Government which have done work in the State of Jharkhand under Corporate Social Responsibility (CSR) along with the details of such work and the names of such Undertakings;

(b) the amount of money spent by the above CPSUs in the State of Jharkhand during each of the last three years and the items on which it has been spent; and

(c) the names of CPSUs which have not spent any fund under CSR?

(a) to (c): The CSR framework is disclosure based and companies are required to file details of CSR activities annually in the MCA21 registry. All data related to CSR filed by companies in MCA21 registry, including Development Sector-wise, State-wise and Company-wise, is available in public domain at <u>www.csr.gov.in</u>.

On the basis of annual filings made by Companies in the MCA21 registry, the details of the CSR expenditure incurred by the CPSUs in the state of Jharkhand are given below:
