#### **GST** collection

862. Shri Digvijaya Singh:

Will the Minister of FINANCE be pleased to state:

- (a) the amount of GST collected annually in the country from July 1, 2019, to July 1, 2024, year-wise;
- (b) the total number of small taxpayers and the amount of GST collected from them during this period;
- (c) the number of medium sized taxpayers, and the percentage of the total GST they have contributed; and
- (d) the number of wealthy (Super rich) taxpayers in the country, and what percentage of the GST was contributed by them?

### Approach:

- 1. Taxpayer Classification: Taxpayers have been categorized based on their total turnover for each Financial Year (FY):
  - Taxpayers with turnover exceeding 250 crores were classified as Large.
  - Taxpayers with turnover between 50 crores and 250 crores were categorized as Medium.
  - Taxpayers with turnover between 5 crores and 50 crores were marked as Small.
  - Taxpayers with turnover below 5 crores were designated as Micro.
- 2. Total Cash Deposited: Total cash deposits are aggregated under different heads (CGST+SGST+IGST+Cess) for each FY to derive the overall collection.
- 3. Contribution Ratio: To determine the percentage contribution of each category, the total collection of each category is divided by the total collection for the respective financial year.
- 4. Inclusion of Special Categories: The analysis also covers composition taxpayers and other categories such as Casual Taxpayers, Non-Resident Taxpayers, and E-commerce entities.
