Failure of co-operative banks

877 Shri Pramod Tiwari:

Will the Minister of **Finance** be pleased to state:

- (a) whether after 2014, a number of co-operative banks-both urban and rural-were closed due to failure:
- (b) if so, the details thereof and the reasons therefor;
- (c) whether RBI has expressed concern over the elevated non-performing assets of urban cooperative banks; and
- (d) if so, the way RBI proposes to expand the operations of cooperative banking sector and improve their financial health?

Answer

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PANKAJ CHAUDHARY)

(a) to (d) As informed by National Bank for Agriculture and Rural Development (NABARD), none of the Rural Cooperative Banks viz. State Cooperative Banks (StCBs)/District Central Cooperative Banks (DCCBs) have been closed since 2014. Further, Reserve Bank of India (RBI) has informed that licenses of 78 Urban Cooperative Banks (UCBs) were cancelled after 2014. The list of these UCBs is provided in Annexure-I. The reasons for cancelling these licenses were, among others, inadequate capital, poor earning prospects, deteriorating financial position, and the continuation of operations being prejudicial to the interests of depositors and the public at large.

An increase in non-performing assets (NPAs) can be attributed to various factors, including macroeconomic conditions, sectoral issues, global business environment etc. RBI has taken several initiatives aimed at timely identification and resolution of stressed assets with the banks' boards entrusted with the responsibility of ensuring effective oversight. To address the issue of elevated NPAs, RBI has issued 'Prudential Guidelines on Restructuring of Advances by UCBs' and 'Guidelines on the Transfer of Stressed Loans'.

RBI has implemented several measures to expand the operations and strengthen the financial health of cooperative banks, which, inter alia, include:

Urban Cooperative Banks (UCBs):

i. Increased Housing Loan Limits.

- ii. RBI has mandated a phased approach for Urban Cooperative Banks (UCBs) to comply with a Priority Sector Lending (PSL) target of 75% of adjusted net bank credit (ANBC) or credit equivalent amount of off-balance sheet exposure (CEOBSE) by March 31, 2026.
- iii. UCBs have to adhere to prudential exposure limits of 15% for a single borrower/party and 25% for a group of connected borrowers/parties, based on their Tier-I capital. Additionally, at least 50% of their loans must be in amounts not exceeding ₹25 lakh or 0.2% of Tier-I capital, up to a maximum of ₹1 crore per borrower/party.

Rural Cooperative Banks (RCBs):

- i. RCBs have been permitted to extend finance to Commercial Real Estate Residential Housing (CRE-RH) sector within the existing housing finance limit of 5% of their total assets.
- ii. Increased Housing Loan Limits.
