900. SHRI A. A. RAHIM:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of the amount allocated to each state for the activities of the National Health Mission (NHM) in the last five years, year-wise ;
- (b) the details of the amount yet to be sanctioned by the Central Government to the State of Kerala for the activities of the NHM; and
- (c) the reasons for this inordinate delay?

**THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE
(SMT. ANUPRIYA PATEL)**

(a) to (c): With the objective of attainment of universal access to equitable, affordable and quality health care services, the Ministry of Health & Family Welfare is implementing National Health Mission. Government provides technical and financial support to the States/UTs for improvement in health infrastructure, availability of adequate human resources to health facilities, improve availability and accessibility to quality health care especially for the underserved and marginalized groups. Further, funds are released by the Ministry under National Health Mission based on the fulfillment of Department of Expenditure conditionalities by States/UTs including Kerala. The details of Central Releases under the National Health Mission (NHM) from FY 2019-20 to 2023-24 and Central Allocation and Central Releases for the FY 2024-25, State/UT-wise and year-wise is at Annexure. Funds under NHM are released based on the receipt of proposals from the States/UTs and compliance of provisions as contained in the schematic guidelines.

Further, as per the DoE guidelines, 25% of the allocated amount for the FY 2024-25 i.e. Rs. 102.90 Cr. (Cash) and total of Rs. 126.81 Cr. has been released to the State of Kerala till date in FY 2024-25.
