FUNDS ALLOCATED UNDER ABDM

Will the Minister of **HEALTH and FAMILY WELFARE** be pleased to state:

(a) the details of funds allocated, released and utilised under Ayushman Bharat Digital Mission for development of infrastructure and digital eco-system in the country during the last three years and the current year till date, year-wise and State-wise; and

(b) the details of number of Ayushman Bharat Health and Wellness Centres (AB-HWCs) now renamed as Ayushman Arogya Mandirs (AAMs) established and operationalized as on date, State-wise?

(a) and (b) Ayushman Bharat Digital Mission (ABDM) launched in September 2021, aims to create the world's largest digital health ecosystem, supporting universal health coverage and developing the backbone necessary to support the integrated digital health infrastructure of the country.

The core components of the Mission include Ayushman Bharat Health Account (ABHA) for citizens (erstwhile Health ID), Health Professional Registry (HPR), Health Facility Registry (HFR) and ABHA App.

ABDM is a Central Sector Scheme with proposed budget of Rs 1600 crore for five years including the following items:

- Digital ICT Systems + software: Rs. 667.96 Crore
- Management Salaries & Office Space: Rs. 200 Crore
- IEC and Capacity Building: Rs. 200 Crore
- Miscellaneous (at 3%): Rs. 32.04 Crore
- HR Support to States/UT for implementing ABDM – Rs. 500 Crore

ABDM has dedicated funding for human resources (HR) and capacity building (CB) as well as Information Education and Communication (IEC) activities earmarked for all the States and Union Territories (UTs) in the country from the FY 2021-22 to FY 2025-26.

To onboard the states and streamline the processes, detailed guidelines have been formulated by NHA for setting up of State Office for ABDM, for IEC/CB budgets of the state, for requirement of IT Infrastructure, for initiating Microsites, for Incentive Scheme, for capacity building etc.

As of now, Total Rs. 74.70 Cr. have been released to all States/UTs under CB/IEC, HR, Microsite, admin heads. State wise, year wise breakup is placed at **Annexure-I**.

Apart from the that, Digital Health Incentive Scheme (DHIS) was launched in 2023 under which financial incentives are provided to bolster adoption and encourage participation in the ABDM ecosystem. Under this scheme total Rs. 24.91 Cr. has been released to health facilities directly for development of health facilities. State wise, year wise breakup is placed at **Annexure-II**.

The State-wise list of number of Ayushman Arogya Mandirs (AAMs) operationalized as on 30.06.2024 is attached at **Annexure-III**.
