IMPLEMENTATION OF PMJVK

768. SHRI A. A. RAHIM

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) the quantum of fund which were allotted under the Pradhan Mantri Jan Vikas Karyakram (PMJVK) scheme to States in the last five years, year-wise; and
- (b) how much of the project allocation is now due to Kerala and the reasons for the delay in the allocation?

ANSWER

- (a) Pradhan Mantri Jan Vikas Karyakram (PMJVK) is a demand driven scheme and State/ UT-wise allocation of funds is not made under it. However, the year-wise details of the funds released for proposals approved under PMJVK during the last five years to all the States/UTs including the State of Kerala, is at **Annexure I**.
- (b) Under PMJVK the beneficiary State/UT have to meet some conditions in terms of the guidelines issued by the Department of Expenditure, Ministry of Finance to be eligible to get the next installment of funds. As per the records available in the Ministry of Minority Affairs presently, the State of Kerala has an amount of Rs. 88.03 Crore as unspent balance including an amount of Rs.67.54 Crore is in its Single Nodal Account for execution of already approved projects under the scheme.
