RE-ESTABLISHING OF NAI UDAAN AND NAYA SAVERA SCHEMES

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) whether Government plans to re-establish schemes like Nai Udaan and Naya Savera which promote education among religious minorities in the country;
- (b) if so, the details thereof and if not, the reasons therefor; and
- (c) the budget allocation for educational scholarship schemes for minorities in the last five years, year-wise, and the amount of money spent, State-wise?

ANSWER

(a) and (b): The Ministry of Minority Affairs has revamped its programmes/Schemes to align with the needs and requirements for socio-economic/education empowerment of six notified minority communities. Accordingly, the Ministry is implementing various Programmes/Schemes including Pradhan Mantri Virasat Ka Samvardhan, Pradhan Mantri Jan Vikas Karyakaram, various Scholarship Schemes including scholarship to meritorious candidates, Jiyo Parsi, etc.
