SETTING UP OF ENGINEERING CLUSTERS UNDER IIUS

1320 DR. BHIM SINGH:

Will the Minister of **Commerce and Industry** be pleased to state:

- (a) whether Government has set up engineering clusters in the country under Industrial Infrastructure Upgradation Scheme (IIUS);
- (b) if so, the details thereof, district-wise, region-wise including the State of Bihar;
- (c) the details of amount of funds sanctioned/allocated/released and utilised so far for the said clusters, the district-wise/region-wise and cluster-wise; and
- (d) the details of progress made so far in this respect?

ANSWER

**THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE & INDUSTRY
(SHRI JITIN PRASADA)**

(a) to (d): Yes Sir. Industrial Infrastructure Up-gradation Scheme (IIUS) was launched in 2003 with the objective of enhancing industrial competitiveness of domestic industry by providing quality infrastructure through public private partnership in selected functional clusters/locations which have potential to become globally competitive. The Scheme was recast in February, 2009 on the basis of an independent evaluation to strengthen the implementation process. A modified version of IIUS viz. 'Modified Industrial Infrastructure Up-gradation Scheme (MIIUS)' was notified in July 2013. Under MIIUS, projects have been undertaken to upgrade infrastructure in existing Industrial Parks/ Estates/ Areas. The scheme has been discontinued since 31.03.2017. Under IIUS/MIIUS, central grant of Rs. 1803.244 crore has been released to various projects.

There is no engineering cluster project set up in the State of Bihar under Industrial Infrastructure Upgradation Scheme (IIUS). District-wise details of **engineering cluster projects** set up in the country and funds sanctioned/ allocated/ released/ utilised along with their progress under the scheme is at **Annexure**.
