- (a) the details of trade between India and European Free Trade Association (EFTA) countries during the last five years, year-wise and country-wise;
- (b) whether India and EFTA entered into trade agreement in March 2024;
- (c) if so, the details thereof;
- (d) the details of the binding commitment of US\$ 100 billion under this agreement and the manner in which it is going to be achieved;
- (e) the details of subjects on which above agreement is going to focus; and
- (f) the timeframe fixed for ratification of the above agreement by EFTA countries—Switzerland, Iceland, Liechtenstein, Norway?

- (b) and (c) Yes, India and EFTA signed the Trade and Economic Partnership Agreement (TEPA) on 10th March 2024. The India-EFTA TEPA is available on https://commerce.gov.in/international-trade/trade-agreements/india-efta-tepa/
- (d) Under TEPA, EFTA has committed to promote foreign direct investments of USD 100 billion in India in the next 15 years. To achieve the desired goal, various investment promotion and cooperation activities are to be taken up as per the Agreement. Additionally, the TEPA provides for an Investment Sub-Committee to complement these efforts and deepen investment relations between India and EFTA states.
- (e) The TEPA agreement comprises of 14 chapters with focus on market access related to goods, rules of origin, trade facilitation, trade remedies, sanitary and phytosanitary measures, technical barriers to trade, investment promotion, market access on services, intellectual property rights, trade and sustainable development, Government Procurement, Competition, Dispute Settlement and other legal and horizontal provisions.
- (f) The TEPA agreement is under the ratification process in the national parliament or legislature of each EFTA country. There is no fixed time frame for this, as the ratification process is different in each of the EFTA countries.
