Will the Minister of PORTS, SHIPPING AND WATERWAYS be pleased to state:

- (a) whether Government has explored possibilities to increase floating jet projects in the State of Tamil Nadu, if so, the details thereof;
- (b) if not, the reasons therefor; and
- (c) the details of current expansion/upgradation works and creation of Hubs in V.O. Chidambaram port, Chennai port, Ennore Port and all other ports in the State of Tamil Nadu?

ANSWER

- (a & b) Yes, Sir. The details of approved floating jetty projects under Sagarmala scheme in the State of Tamil Nadu is placed at Annexure-I.
- (c) The details of expansion/upgradation projects in the ports in the State of Tamil Nadu is placed at Annexure-II. Further, VOC Port has leased land of 500.82 acres to various industries to develop Green Hydrogen/ammonia plant.
