MSME PARKS IN ANDHRA PRADESH

759. SHRI V. VIJAYASAI REDDY:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether Government will assist the State Government of Andhra Pradesh to set up exclusive parks with MSME units across the State;
- (b) whether the parks are expected to attract at least ₹ 15,000 to 25,000 crore and generate huge employment;
- (c) whether any initiative to encourage small entrepreneurs to set up their units in the dedicated parks has been undertaken by the Government; and
- (d) if so, details thereof and if not, reasons therefor?

ANSWER

MINISTER FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI JITAN RAM MANJHI)

- (a) and (b): The Government of India is implementing program /schemes for infrastructure development as follows.
 - (i) Ministry of MSME is implementing Micro and Small Enterprises Cluster Development Programme (MSE-CDP). This is a demand driven scheme. Any State Government including Andhra Pradesh, may take the benefits of this scheme as per their need. Under the scheme, financial assistance is provided for establishment/upgradation of Industrial Areas/Estates/Flatted Factory Complex. The details of approved ongoing and completed Infrastructure Development (ID) Projects/Flatted Factory Complexes in Andhra Pradesh are enclosed at **Annexure I**.
 - (ii) Pradhan Mantri Kisan Sampada Yojana (PMKSY) is being implemented by Ministry of Food Processing Industries (MoFPI) across the country. PMKSY is a comprehensive package which aims at creation of modern infrastructure with efficient supply chain management from farm gates to retail outlets.

- (iii) Ministry of Electronics & Information Technology (MeitY) is implementing, Electronic Manufacturing Clusters (EMC) scheme to provide support for creation of world-class infrastructure along with common facilities and amenities for attracting investment in Electronics System Design and Manufacturing (ESDM) sector in Andhra Pradesh are enclosed at **Annexure II**.
- (iv) The Government of India has also taken up various measures to promote industrial growth and attract new investments i.e. Pradhan Mantri Gati Shakti, National Logistics Policy, Project Monitoring Group (PMG), National Industrial Corridor Development Programme, Industrial Park Rating System (IPRS).

(c) and (d): The Ministry of Micro, Small and Medium Enterprises helps in establishment of MSMEs through its various schemes, programmes and policy initiatives for promotion and development of MSMEs across the country, including Andhra Pradesh. schemes/programmes inter alia include Prime Minister's Employment Generation Programme (PMEGP), Credit Guarantee Scheme for Micro & Small Enterprises (CGTMSE), Micro & Small Enterprises Cluster Development Programme (MSE-CDP), MSME Champions Scheme, Entrepreneurship Skill Development Programme (ESDP), Procurement and Marketing Support Scheme (PMSS), etc. Benefits under these schemes are available to all eligible MSMEs throughout the country.
