MARKET CAP OF ONGC AND CSR ACTIVITY

1569. SMT. SUMITRA BALMIK:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:-

- (a) the total market cap of ONGC, its subsidiaries, their annual profit in the last three years, year-wise including 2024;
- (b) the total CSR spent by ONGC and its subsidiaries during the last three years, State-wise and year-wise;
- (c) whether ONGC has also engaged other implementing agencies in implementation of these activities, if so, details thereof for the last three years; and
- (d) the criteria for allocation of CSR projects?

(a) The total market cap of ONGC and its listed subsidiaries viz. Hindustan Petroleum Corporation Limited (HPCL) and Mangalore Refinery and Petrochemicals Limited (MRPL) in the last three financial years as well as their annual profit is as under:
