SHRI SADANAND MHALU SHET TANAVADE:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the State-wise implementation status of the Jal Jeevan Mission;
- (b) the number of households which have received tap water supply in the current financial year, State-wise details thereof;
- (c) the quantum of funds which have been released by Government to the States for the Jal Jeevan Mission, State-wise details thereof; and
- (d) a State-wise breakdown of implementation progress, including the number of households covered and funds released, with a specific comparison of Goa to other States?

ANSWER

(a) to (d) Government of India in partnership with States, is implementing Jal Jeevan Mission (JJM) – Har Ghar Jal to make provision of tap water supply to every rural household. At the start of Jal Jeevan Mission in August 2019, only 3.23 Crore (16.8%) rural households were reported to have tap water connections. So far, as reported by States/ UTs as on 01.08.2024, around 11.80 Crore additional rural households have been provided with tap water connections, including 41.41 lakh tap water connections in current financial year. Thus, as on 01.08.2024, out of 19.32 Crore rural households in the country, more than 15.03 Crore (77.83%) households are reported to have tap water supply in their homes.

Goa was the first state across the country to achieve Har Ghar Jal status, i.e. 100% households are having tap water supply. As on date, 11 States/ UTs have become ‘Har Ghar Jal’ States/ UT. The year-wise details of tap water connections provided as on 01.08.2024, in Goa along with other States/ UTs, are at **Annex-I**. Similarly, the year-wise details of Central fund released under JJM to the State of Goa and other States/ UTs, are at **Annex-II**.
