(a) to (c) Banks are providing credit linkages to Self Help Groups (SHGs) under various programmes implemented by Government including Deendayal Antyodaya Yojna- National Rural Livelihoods Mission (DAY-NRLM), Pradhan Mantri Mudra Yojna and Stand-Up India.

The details regarding state-wise allocation of funds and disbursement of loans to SHGs under National Rural Livelihoods Mission (NRLM) during the last 3 years as received from Department of Rural Development, are attached as Annexure-I and Annexure-II respectively.
