174*. SMT. PRIYANKA CHATURVEDI:

Will the Minister of Women and Child Development be pleased to state:

- (a) the allocation and expenditure of Sambal Scheme in the year 2022-2023 and 2023-2024, component wise;
- (b) the number of beneficiaries of the Sambal Scheme, State-wise; and
- (c) the reason for under-utilization of funds for Sambal scheme in the Financial Year 2021-2022 and 2022-2023?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI ANNPURNA DEVI)

(a) to (c): A Statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY TO PART (A) TO (C) OF RAJYA SABHA STARRED QUESTION NO. 174* FOR ANSWER ON 07.08.2024 ASKED BY SMT. PRIYANKA CHATURVEDI REGARDING 'PROGRESS ON SAMBAL SCHEME'

(a) to (c): The One Stop Centre (OSC), Women Helpline (WHL), Beti Bachao Beti Padhao (BBBP) and Nari Adalat (NA) are sub-schemes of Sambal component of Mission Shakti. Details of scheme-wise Revised Estimates (RE) and Expenditure during the financial years 2021-22, 2022-23 and 2023-24 are as under:

The reasons for under-utilization of funds for Sambal scheme in the Financial Year 2021-22 and 2022-2023 are as follows:

Financial Year 2021-22

The grants-in-aid to the States and Union Territories were released based on the utilization of funds made available to them in the previous financial years and requirement of funds of the States/UTs in the current year for implementation of the schemes. In the OSC scheme, the funds are primarily meant for incurring expenditure on salary, wages and services of human resources. Low recruitment of manpower resources by the States/UTs led to savings of funds with majority of the States/UTs. Apart from this, the budget was allocated for operationalization of 743 approved OSCs while only 708 OSCs were actually operationalised. Further, delay in submission of Utilization Certificates and settlement thereof leads to non-release of funds as per General Financial Rules, 2017.

With regard to the Women Helpline (WHL) sub-scheme, the funds are primarily meant for incurring expenditure on salary engaged for providing services to the women and

payment of telephone rent. Low engagement of staff in the Women Helpline scheme by the state governments also led to savings with the States/UTs.

BBBP scheme emphasizes on creating positive behavioural and social change towards the girl child through awareness generation activities. It was implemented by District administration involving community mobilization and participation at the district level and funds were released directly to the BBBP dedicated account of the 405 selected districts for multi-sectoral interventions as per the proposals received from respective districts. Further, for the release of subsequent installment the districts had to furnish Utilization certificate (UC), Statement of Expenditure (SoE), financial progress of expenditure and physical progress report. The subsequent installment was released taking into account the balance unspent amount. This financial year along with previous financial year were affected by COVID-19 which led to lesser activities and higher unspent balance. Further, delay in submission of Utilization Certificates and settlement thereof leads to non-release of funds as per General Financial Rules, 2017.

Financial year 2022-23

In this Financial Year, with a view to have more effective cash management and bring more efficiency in the public expenditure management, the Ministry of Finance, Department of Expenditure vide instructions dated 23.3.2021 mandated every State Government/UT Administration (with legislature) to designate a Single Nodal Agency (SNA) for implementing each Centrally Sponsored Scheme (CSS). Department of Expenditure vide instructions dated 2.12.2022 (Annexure-I) directed routing funds only through SNA for Sambal schemes also. Accordingly, the States/UT Administrations concerned took considerable time to complete SNA procedure (Annexure-II) for all components of Sambal sub-scheme. Further, the issue of unspent balance as in the previous financial years, affected the utilization of funds.

(b): The details of State/UT-wise number of women assisted through OSC and Women Helpline (WHL) are annexed at **Annexure-III** and **Annexure-IV** respectively.

Further, Beti Bachao Beti Padhao (BBBP) primarily focuses on creating behavioural and social change in the way the girl child is perceived across the country. The nature of BBBP is such that beneficiaries' numbers are not measurable.

Subject: Revised procedure for flow of funds under Centrally Sponsored Schemes – one time exemption for non-SNA expenditure by States - reg.

Sir/Madam,

The undersigned is directed to refer to DoE's guidelines on revised procedure for flow of funds for Centrally Sponsored Schemes issued vide OM No. 1(13)/ PFMS/FCD/2020 dated 23rd March, 2021. As per the guidelines, the State Government should transfer the Central share of funds received under a CSS to the SNA account along with the commensurate State share. Further, any scheme related expenditure should be incurred by the State Government from the SNA account only. The SNA reports in PFMS are configured to capture the fund flow/expenditure in accordance with the DoE's guidelines.

- 2. However it has been observed that even after onboarding of the State Linked Schemes (SLS) on PFMS, some States have incurred expenditure under the scheme either directly from the treasury or by transferring funds to non SNA accounts. Such expenditure done in violation of DoE's guidelines is not captured/recognized in PFMS. Accordingly, for each such fund releases to non-SNA accounts/expenditure incurred directly from State treasury, the SNA 09 report reflects a 'deficit' of the equivalent amount in the release of scheme funds from State treasury to the SNA account. The 'deficit' invokes a validation check in PFMS which prevents further release of funds by Departments to such States.
- 3. Requests have been received from State Governments and Ministries/Departments to condone such expenditure incurred by the State Governments in the past in violation of DoE's guidelines and to include the same in SNA reports to prevent invocation of validation check.
- 4. The matter has been examined in this Department. It has been decided to consider such cases for granting one time exemption. Accordingly you are requested to provide details of CSS expenditure made directly from treasury or through non-SNA accounts after onboarding of SLS on PFMS and up to 30.11.2022 in the attached format (Annex

IA, IB) and seek one time exemption from this Department for including the expenditure so incurred in the SNA reports.
