NEW NATIONAL HIGHWAYS IN TAMIL NADU

1851. SHRI C. VE. SHANMUGAM:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:

- (a) the details of State Highways that have been converted into National Highways in the Country during the last three years, including the State of Tamil Nadu, year-wise, Statewise;
- (b) the ongoing projects of conversion of State Highways into National Highways in the Country, including Tamil Nadu;
- (c) the details of funds being allocated for this purpose during the last three years, Yearwise, State-wise vis-à-vis. the progress achieved; and
- (d) the steps taken by Government to complete the ongoing projects soon?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

(SHRI NITIN JAIRAM GADKARI)

- (a) State / Union Territory (UT) wise details of State Roads, including State Highways (SHs) and greenfield stretches, notified as National Highways (NHs) during the last three years, including for the State of Tamil Nadu, are at Annexure-I.
- (b) Works on notified NHs are taken up based on the traffic density, condition of the road, inter-se priority and availability of funds. At present, 1,379 NHs projects in 33,674 km length costing Rs. 8,26,914 Crore are under construction in the country, including 58 NHs projects in 1,223 km length costing Rs. 39,626 Crore in the State of Tamil Nadu.
- (c) State / UT -wise details of funds allocated and expenditure incurred towards development and maintenance of NHs during the last three years are at Annexure-II.

State / UT -wise details of NH length constructed during the last three years are at Annexure-III.

(d) The Government has taken number of steps to ensure timely completion of projects like awarding projects after adequate preparation in terms of land acquisition and preconstruction

activities, streamlining (i) land acquisition notification process and (ii) simplifying procedure for approval of GAD (General Arrangement Drawing) by Railways, apart from other initiatives like rationalized exit for equity investors, premium re-scheduling, revamping dispute resolution mechanism, relaxations in contract provisions under "Atmanirbhar Bharat" to improve liquidity of funds available with contractors/developers during COVID period, periodic reviews of projects at various levels, etc.
