GENDER-SPECIFIC PLACEMENTS UNDER PMKVY SCHEME

1873. SHRI G.C. CHANDRASHEKHAR:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) the details of candidates trained under the Pradhan Mantri Kaushal Vikas Yojana (PMKVY), categorized by gender (male, female, non-binary), State-wise, during last five years;
- (b) the details of placements offered to candidates trained under PMKVY in the last two years, State-wise and gender-wise;
- (c) whether Government is aware of the low placement rate in the program; and
- (d) if so, whether Government could provide details and outline plans to enhance placement rates?

ANSWER

- (a) The details of candidates trained/oriented under the Pradhan Mantri Kaushal Vikas Yojana (PMKVY), categorized by gender (male, female, non-binary), State-wise, during last five years is given in **Annexure-I**.
- (b), (c) and (d) The Ministry of Skill Development and Entrepreneurship has been implementing Pradhan Mantri Kaushal Vikas Yojana (PMKVY) since 2015, for imparting skill development training through Short-Term Training (STT) (including Special Project) and up-skilling and reskilling through Recognition of Prior Learning (RPL) to youth across the country.

Under PMKVY, placements were tracked in the Short-Term Training (STT) component in the first three versions of the Scheme which is PMKVY 1.0, PMKVY 2.0 and PMKVY 3.0 implemented from FY 2015-16 to FY 2021-22. Placement is delinked from PMKVY 4.0, the current version of the scheme under implementation from FY 2022-23 onwards, i.e. from last two years.

PMKVY 4.0 is being implemented as a Demand-Driven scheme to skill the candidates. However, PMKVY 4.0 emphasizes on increasing the employability of the candidates by offering Industry Ready, Future Ready and Modern Skilling in various domains. The scheme focuses on new age and emerging courses such as Drone, Artificial Intelligence (AI), Internet of Things (IoT), 3D Printing, Block Chain, Mechatronics, Robotics, etc. On-the-Job Training (OJT), mandatory employability skills module, focus on upskilling, Aadhaar authenticated registration of candidates, blended delivery of courses, etc. are some of the important aspects of the scheme.
