IMPLEMENTATION OF LAKHPATI DIDI SCHEME

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details on the number of LakhpatiDidis in the country;
- (b) the details of outcomes achieved under the LakhpatiDidi initiative of Government sinceits inception; and
- (c) the details of LakhpatiDidi from minority communities benefitted under the scheme,community wise?

ANSWER MINISTER OF RURAL DEVELOPMENT (SHRI SHIVRAJ SINGH CHOUHAN)

(a) to (c): A Statement is laid on the Table of the House.

STATEMENT (a) to (c) REFERRED TO IN REPLY TO RAJYA SABHA STARRED QUESTION NO. *202 TO BE ANSWERED ON 09.08.2024.

- (a): DeendayalAntyodayaYojana National Rural Livelihoods Mission (DAY-NRLM) is being implemented in 7,135 blocks in 742 districts across 28 States and 6 Union Territories (UTs). Cumulatively, 10.05 crore women have been mobilized into more than 90.86 lakh Self Help Groups (SHGs). Out of these SHG members, more than 1 crore SHG members have an annual income of more than Rs. 1 Lakh, i.e., they are LakhpatiDidis. The State/UT wise numbers of LakhpatiDidis is attached in **Annexure-I.**
- (b): DAY NRLM is being implemented with the objective of organizing the rural poor women into SHGs and continuously nurturing and supporting them till they attain appreciable increase in incomes over a period of time and improve their quality of life and come out of abject poverty. The Ministry is working not only to strengthen institutional structure and financial linkage of the SHGs, but also to enhance and diversify livelihoods of the SHG members. LakhpatiDidi is an output of these interventions.

The key outcomes of DAY-NRLM including LakhpatiDidis are attached in Annexure-II.

(c): As per the data base maintained by DAY-NRLM, there are 10,80,107 Minority SHGs. (Minority SHG is a group of women with more than 50% members from the minority community). In these SHGs, there are 99,13,879 members of the Minority community. The community wise details are in **Annexure-III**. Currently DAY-NRLM is not maintaining Minority information in the Lakhpati Survey database.
