# GOVERNMENT OF INDIA MINISTRY OF HOUSING AND URBAN AFFAIRS RAJYA SABHA UNSTARRED QUESTION NO. 76 ANSWERED ON 25/11/2024

#### URBAN HOUSEHOLDS CONNECTED TO PIPED SEWER SYSTEM

#### 76. SHRI MUKUL BALKRISHNA WASNIK:

#### Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details regarding urban households connected to piped sewer system, State-wise;
- (b) the details regarding urban households having septic tank sewer system in place, State-wise;
- (c) whether Government has taken any steps to ensure that all urban households get connected to piped sewer system and will have septic tank sewer system in a specified time-frame; and
- (d) if so, the details thereof and if not, the reasons therefor?

#### **ANSWER**

### THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI TOKHAN SAHU)

- (a) & (b): As per the Census of India 2011, the details of state-wise urban households connected to piped sewer system and septic tank is at Annexure-1.
- (c) & (d): Sanitation being a state subject, management of sewerage and septage system in the cities/towns is the responsibility of the State Governments and the Urban Local Bodies (ULBs)/Urban Development Authorities. However, Government of India supplements the efforts of the States and Urban Local Bodies (ULBs) in providing infrastructure for basic services such as sewerage and septage infrastructure in urban areas through its various flagship Missions like Atal Mission for Rejuvenation and Urban Transformation (AMRUT) and AMRUT 2.0.

MoHUA is implementing AMRUT in selected 500 cities (485 cities including 15 merged cities) and towns across the country covering approximately 65% of urban population. Under AMRUT, ₹32,456 crore (42%) has been allocated to sewerage and septage projects. So far, 888 projects worth ₹34,487.86 crore have been grounded in the sewerage and septage management sector, of which work worth ₹32,022 crore have been physically completed. Till date, 149 lakh sewer/septage connections [including households covered through Fecal Sludge and Septage Management (FSSM)] have been provided through AMRUT and in convergence against targeted 145 lakh sewer/septage connections.

In addition, AMRUT 2.0 scheme has been launched on 1st Oct 2021 in all the ULBs/cities, enabling the cities to become 'self-reliant' and 'water secure'. Providing universal coverage of sewerage & septage management in 500 AMRUT cities is one of the major focus areas of AMRUT 2.0. Under AMRUT 2.0, so far 595 projects worth ₹68,198 crore have been approved by MoHUA under Sewerage and septage management sector for augmentation of around 151.74 lakh new/service sewer connections, 35,871 km sewerage network and 6784 MLD of sewage treatment capacity.
