REGARDING “ACHIEVEMENTS OF PLISFPI AND PMKSY”**

(a). Ministry of Food Processing Industries is implementing a centrally sponsored umbrella scheme Pradhan Mantra Kisan Sampada Yojana (PMKSY). Under component schemes of PMKSY, Ministry provides financial assistance for setting up food processing industries and related infrastructure. PMKSY is demand driven in nature and applications are invited through Expression of Interest (EoI) from all over India.

The details of the number of projects approved since inception of component schemes of Mega Food Parks, Integrated Cold Chain & Value Addition Infrastructure and Creation of Infrastructure for Agro Processing Clusters under Pradhan Mantri Kisan Sampada Yojana (PMKSY) are as follows:

(b). Ministry of Food Processing Industries is implementing PLI Scheme for FPI during 2021-22 to 2026-27 with an outlay of ₹ 10,900 crores. As on date incentive amount to the tune of ₹1084.011 Crores in 85 eligible cases has been disbursed by the Government. Investment of ₹ 8910 Crores has so far been reported at 213 locations across the length and breadth of the country. As per the data reported by the beneficiaries of the Scheme, 2,89,832 direct and indirect employment opportunities have been created after implementation of the scheme.
