Janaushadhi Kendras in Bihar

1611 Shri Sanjay Kumar Jha:

Will the Minister of **Chemicals and Fertilizers** be pleased to state:

- (a) whether Government has details about the number of Pradhan Mantri Bhartiya Janaushadhi Kendras established in the State of Bihar since the inception of the scheme;
- (b) if so, the details thereof, district-wise;
- (c) whether any financial/special support is provided to applicants belonging to SC/ST community for setting up of Janaushadhi Kendra;
- (d) if so, the details thereof;
- (e) whether Government conducts regular quality checks/audits at such stores to ensure good quality medicines for the patients; and
- (f) if so, the details thereof?

ANSWER

**THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS & FERTILIZERS
(SMT. ANUPRIYA PATEL)**

(a) & (b): Under Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP), a total of 14,320 Jan Aushadhi Kendras (JAKs) have been opened till 30.11.2024 across the country, of which 747 JAKs have been opened in the State of Bihar. The district-wise number of JAKs opened in Bihar is enclosed in the **Annexure**.

(c) & (d): All JAK owners are eligible for an incentive @ 20% of monthly purchases made by them, subject to a ceiling of Rs. 20,000/- per month. In addition, a one-time incentive of Rs. 2.00 lakh is provided to the JAKs opened in North-Eastern States, Himalayan areas, Island territories, and areas mentioned as aspirational districts by NITI Aayog or opened by women entrepreneurs, ex-servicemen, Divyang, SC & ST in the form of support towards furniture, computers, refrigerators, and other fixtures.

(e) & (f): Pharmaceuticals & Medical Devices Bureau of India (PMBI), the implementing agency of the scheme, procures medicines only from World Health Organization – Good Manufacturing Practices (WHO-GMP) certified suppliers to ensure quality of the products. Further, each batch of drug is tested at laboratories accredited by ‘National Accreditation Board for Testing and Calibration Laboratories (NABL)’ before their dispatch to JAKs. Marketing Officers of PMBI periodically inspect JAKs to ensure that good quality medicines are provided to the patients.
