Corporate sector growth and company registrations in Telangana

## 1656. Shri Ravi Chandra Vaddiraju:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) whether the Ministry has noted that Telangana ranks third (as per MCA monthly information bulletin report for September, 2024) in South India in terms of total registered companies after Karnataka and Tamil Nadu;
- (b) the sector-wise distribution of active companies in Telangana and their contribution to the State's economy;
- (c) whether any comparative study has been conducted to understand why Karnataka and Tamil Nadu have higher company registrations, if so, the details thereof; and
- (d) the specific measures to make Telangana more attractive for new company registrations?

## **ANSWER**

- (a): Yes sir, Telangana ranks third in South India after Karnataka and Tamil Nadu in terms of total registered companies which includes active companies and companies closed, under liquidation, under process of striking off, dormant etc. as per MCA monthly information bulletin for September 2024.
- (b) The sector-wise distribution of active companies as on 30<sup>th</sup> November, 2024 in Telangana are as under:

Total turnover of such active companies for the Financial Year 2023-24 is around 11 Lakh Crores rupees as per filings done upto 30<sup>th</sup>November, 2024 in MCA 21 Registry.

- (c) and (d): This Ministry administers the Companies Act, 2013 by regulating registration, functioning of companies etc and to improve ease of doing businessin the whole country as regards registration of companies and Limited Liability Partnerships (LLPs), some of the major steps taken are as under:-
  - (i) Setting up of a Centralized Registrar of Companies (CRC) for incorporation to provide uniformity in the incorporation process.
  - (ii) Introducing e-Form SPICe+ along with a linked form called AGILE PRO-S for providing different services at one place such as Name Reservation, Incorporation, Allotment of PAN, TAN, DIN, EPFO Registration, ESIC Registration, GST number, opening of Bank Account etc. at the time of incorporation of company to start the business immediately. Similarly, new e-Form Fillip (Form for incorporation of LLP) was introduced for providing the same services in a single application.
  - (iii)Zero fee for incorporation of company with authorized capital up to Rs.15.00 Lakh.

As on date, a comparative study has not been conducted by this Ministry to understand differences in number of company registrations across States.
