Conservation of vultures

1986. SMT. KIRAN CHOUDHRY:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the measures taken by Government for conservation of Vultures particularly in Haryana;
- (b) the details of vultures breeding centres set up in the country in the last three years, particularly in Haryana;
- (c) whether any special fund has been created dedicated to vulture conservation; and
- (d) if so, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI KIRTI VARDHAN SINGH)

- (a) and (b) The important steps taken to save vultures include the following:
 - (i) All the nine species of vultures found in Indiaare listed in the Schedule I of the Wild Life (Protection) Act, 1972, thereby providing them with the highest degree of protection.
 - (ii) In August 2006, the Drugs Controller General of India banned the use, sale and manufacture of Diclofenacveterinary use.
 - (iii) The vial size of the Diclofenac use for human use has been restricted to 3 ml to prevent its misuse in treating livestock.
 - (iv) The Government of India has restricted the packaging of multi-dose vial of Diclofenac to single dose for human use in July, 2015.
 - (v) The Government of India has prohibited the manufacture, sale and distribution of Ketoprofen and Aceclofenac and their formulations for veterinary use in July, 2023.
 - (vi) Over-counter sale of veterinary non-steroidal anti-inflammatory drugs without prescription are prohibited.
 - (vii) An Action Plan for Vulture Conservation was launched by the Ministry in November, 2020.
 - (viii) Vultures have been identified as one of the 22 species for providing funding support to the States/Union Territories under Centrally Sponsored Scheme-Development of Wildlife habitats for their conservation of vultures under the Species Recovery Programme.
 - (ix) Eight Vulture Conservation Breeding Centres have been set up across India.

The first Vulture Conservation Breeding Centre was established in 2004 at Pinjore, Haryana. Subsequently, two more centres were set up at Rajabhatkhawa, West Bengal (2006) and Rani, Assam (2008). The Central Zoo Authority sanctioned the setting of Vulture Conservation Breeding Centre sat Van Vihar National Park, Bhopal, Madhya Pradesh; Nandankanan Zoo, Bhubanewhwar, Odihsa; Nehru Zoological Park, Hyderabad, Telangana, and Sakkarbaug Zoo, Junagadh, Gujarat in 2007 and Muta Zoo, Ranchi, Jharkhand in 2009.

(c) and (d) The Ministry provides financial assistance to State/UT Governments under the Centrally Sponsored Scheme –Integrated Development of Wildlife Habitats which includes 'Development of Wildlife Habitats' and 'Project Tiger and Elephant' which aims at conservation and protection of wildlife and improvement of habitat including vultures.

The continuation of the scheme as WDC-PMKSY 2.0 has been approved by the Government on 15 December 2021. Under WDC PMKSY 2.0, total 1150 watershed projects covering an area of 50.16 lakh ha at a total cost of Rs.12303.33 crore have been sanctioned to States/UTs by the Department of Land Resources, GoI for implementation of projects from FY 2021-22 to FY 2025-26. An amount of Rs.4527.92 crore (as on 04.12.2024) has been released as Central share to the States/UTs for 6 States covering Western Ghat region. The State-wise details of projects sanctioned area covered, project cost and Central funds released from 2019-20 to 2024-25 (as on 04.12.2024) for these States is given at **Annexure I.**

The activities undertaken in scheme inter alia include soil & moisture conservation measures, rain water harvesting measures, afforestation, horticulture and pasture development, livelihood activities, production system support and capacity building, etc.

End-line evaluation reports of completed projects reveal that there is significant improvement in availability of surface & ground water, increase in productivity, vegetative cover, enhanced livelihood opportunities and household incomes in project areas.

The details of physical and financial progress made under WDC-PMKSY2.0 in during the 2019-2024 for 6 States of Western Ghat region are given at **Annexure II.**

(c) & In consonance with the National Forest Policy 1988, the local communities are involved through Joint Forest Management Committees (JFMCs) in the management of forests and various afforestation activities. Various schemes including Green India Mission are being implemented by the Ministry and the State/UT governments with the participation of these committees. Further, for the management of the Wildlife Protected Areas, Eco Development Committees (EDCs) are also formed to ensure people participation in wildlife conservation.
