- (a) The Aspirational Districts Programme monitors the progress of Aspirational Districts on 49 Key Performance Indicators across sectors such as health, nutrition, education, agriculture and water resource, financial inclusion, skill development and basic infrastructure. There are 10 Aspirational Districts in Odisha. List of Aspirational Districts in Odisha and the district-wise status of their performance is attached as Annexure I. The same is also available on the Champions of Change Portal (http://championsofchange.gov.in), which is publicly accessible.
- (b) Details of indicator-wise performance of the Aspirational Districts of Odisha are attached as Annexure II. The same is also available on the Champions of Change Portal (http://championsofchange.gov.in), which is in the public domain.
- (c) The Aspirational Districts Programme uses a 3C strategy Convergence, Collaboration, and Competition to provide targeted support for the holistic development of Aspirational Districts. Convergence ensures the alignment of resources from Central and State Government schemes to address critical developmental gaps effectively. Collaboration fosters seamless coordination between the Central Government, State Governments and districts to implement focused interventions. The programme actively engages development partners to provide additional expertise and support in areas requiring special attention. A sense of healthy competition is encouraged by ranking districts based on their incremental progress across key performance indicators every month, fostering a spirit of continuous improvement.
