- (b) the number of Garima Grehs functioning in the country, State-wise details thereof;
- (c) the number of transgender beneficiaries residing in the shelter homes, State-wise details;
- (d) the details of funds released and utilized for each Garima Greh including the amount allocated, released and percentage of the amount utilized; and
- (e) the number of transgender beneficiaries of Ayushman Bharat Yojana, State-wise?

- (e) Memorandum of Understanding (MoU) with National Health Authority (NHA) for convergence of Ayushman Bharat scheme of NHA with Support for Marginalized Individuals and Livelihood Enterprise (SMILE) Scheme has been entered into for providing health facilities under Pradhan Mantri Jan Arogya Yojana to Transgender persons.
