**PRADHAN MANTRI JANJATIYA UNNAT GRAM ABHIYAN**

3015 SMT. RENUKA CHOWDHURY:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether Pradhan Mantri Janjatiya Unnat Gram Abhiyan (PMJUGA) is only a combination of various existing schemes across different ministries for the welfare of Tribals or it has introduced new features, if so, the details of the new features and targets;
- (b) whether the funding of PMJUGA is collectively maintained by various ministries, if so, the details thereof;
- (c) the details of the nodal agency responsible for monitoring the development under PMJUGA; and
- (d) the details of the differences between PMJUGA and Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JANMAN)?

**ANSWER**

(a) & (d): As informed by the Ministry of Tribal Affairs, Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM JANMAN) was launched in the Financial Year (FY) 2023-24 for socio-economic development of 75 Particularly Vulnerable Tribal Groups (PVTG) residing in 18 states and one UT with total outlay of Rs.24,104 crore (Central Share: Rs.15,336 crore and State Share: Rs.8,768 crore). The mission aims to provide basic facilities such as safe housing, clean drinking water and improved access to education, health and nutrition, road and telecom connectivity, electrification of un-electrified households and sustainable livelihood opportunities in 3 years. These objectives are planned to be met through 11 interventions implemented by 9 line Ministries. Whereas, Pradhan Mantri Janjatiya Unnat Gram Abhiyan (name as per budget announcement 2024-25) has been launched as Dharti Aaba Janjatiya Gram Utkarsh Abhiyan (DA JGUA) on 2nd October, 2024 with total outlay of Rs.79,156 crore (Central Share: Rs.56,333 crore and State Share: Rs. 22,823 crore). The Abhiyan comprises of 25 interventions implemented by 17 line Ministries and aims to saturate infrastructural gaps in 63,843 villages, improve access to health, education, Anganwadi facilities and providing livelihood opportunities benefiting more than 5 crore tribals in 549 districts and 2,911 blocks in 30 States/UTs in 5 years. Each Ministry has been allocated budget and targets under Abhiyan and responsible for implementing the intervention assigned to it. The Abhiyan also envisages to provide sustainable livelihoods through Tribal Multipurpose Marketing Centres (TMMC) and tourist home stays. Further it also aims to provide benefits of schemes of Department of Agriculture, Animal Husbandry and Fisheries to Forest Rights Act (FRA) Patta holders with changed pattern of assistance where the beneficiary's contribution has been capped at 10%. Interventions and Targets under DA JGUA and PM JANMAN are at **Annexure**.

(b): DA JGUA and PM JANMAN are being implemented through provisioning of funds from various schemes of Central Ministries / Departments under Development Action Plan for Scheduled Tribes (DAPST) comprising both Central Sector and Centrally Sponsored Schemes.

(c): Ministry of Tribal Affairs is the nodal agency responsible for monitoring the development under PM JUGA (renamed as DA JGUA).
