- (d) the details of assets/facilities that have been created in the State of Telangana under the AMRUT Scheme since its inception?

**STATEMENT REFERRED TO IN REPLY TO PART (a) TO (d) OF THE RAJYA SABHA
STARRED QUESTION NO. *65 DUE FOR ANSWER IN THE RAJYA SABHA ON 02
DECEMBER 2024 REGARDING “CITIES COVERED UNDER AMRUT IN TELANGANA”**

(a) to (d): The Atal Mission for Rejuvenation and Urban Transformation (AMRUT) was launched on 25 June 2015 in 500 cities (485 cities including 15 merged cities) and towns across the country. In the State of Telangana, 12 Cities are covered under AMRUT namely, Adilabad, Greater Hyderabad Municipal Corporation (GHMC), Karimnagar, Khammam, Mahbubnagar, Miryalaguda, Nalgonda, Nizamabad, Ramagundam, Siddipet, Suryapet and Warangal.

As reported by the State of Telangana, under AMRUT, 66 projects were taken up which included 27 water supply projects worth ₹1,424.09 crore, 4 sewerage/Septage Management projects worth ₹203.3 crore and 35 Green Spaces & Park projects worth ₹35.69 crore. All these projects have been completed. Details of these projects is given in Annexure-I.

Under AMRUT, 4,336.54 km length of water pipeline & 278.53 km length of Sewer pipeline has been laid, 5.54 lakh water tap connections and 0.87 lakh sewer connections have been provided under AMRUT and convergence. Further, 18.25 MLD Sewage Treatment Plant (STP) capacity and 442.45 acres of green space area has been developed in the State of Telangana under AMRUT.

An amount of ₹1,663.08 crore was sanctioned for these projects, which includes Central Assistance (CA) of ₹832.6 crore. The State has submitted utilization of ₹ 806.21 crore against ₹831.52 crore released under AMRUT.
