**Underutilisation of funds under Department of Land Resources**

**208 Shri Tiruchi Siva:**

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) whether it is a fact that there has been consistent underutilisation of funds allocated for Department of Land Resources since recent past, particularly due to delayed transfer of Central funds to State Level Nodal Agencies;
- (b) if so, the details of underutilisation patterns, State-wise, and the specific factors leading to these delays, including administrative or procedural bottlenecks in fund disbursement; and
- (c) whether Government has taken any steps to expedite the fund transfers and project implementation?

**(a) to (c)** A Statement is laid on the Table of the House.

**Statement referred to in Reply to Parts (a) to (c) of Rajya Sabha Starred Question No. 208 for Answer on 13.12.2024 regarding "Underutilisation of funds under Department of Land Resources"**

**(a) and (b)** No Sir, there has been no delay in release of funds to the States/UTs.

The Department implements two Schemes/Programmes viz. i) Watershed Development Component-Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY) 2.0 and ii) Digital India Land Record Modernization Programme (DILRMP). Both the Schemes have been approved for the period 2021-26.

Funds are released expeditiously on the receipt of proposals from States/UTs as per their eligibility based on utilization of earlier released funds. Details of the funds released/ utilised by the Department during the last three years are given as under:

**(c)** For expeditious transfer and utilization of funds in the Schemes, the Department is regularly monitoring the implementation of the projects with concerned officials of States/UTs, through regular Video Conferences, Review meetings, Regional Review Meetings and field visits by the senior officers of the Department. The progress of the funds utilization by the States/UTs is monitored through PFMS portal on regular basis.
