STATUS OF FOOD PROCESSING SCHEMES IN MAHARASHTRA

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) the current status of mango production clusters in Ratnagiri, Sindhudurg and Raigad districts under Pradhan Mantri Kisan SAMPADA Yojana (PMKSY);
- (b) the status of the products of these districts under 'One District One Product' (ODOP) scheme;
- (c) the details of the progress made in infrastructure creation, marketing and branding under PMFME scheme; and
- (d) the details of projects and financial assistance approved in Maharashtra under Production Linked Incentive (PLI) Scheme?

ANSWER

**THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES
(SHRI RAVNEET SINGH)**

(a). Ministry of Food Processing Industries (MoFPI) has been implementing a central sector umbrella scheme called “Pradhan Mantri Kisan Sampada Yojana (PMKSY)” since 2017-18 across the country. The basic objective of the scheme is to ensure overall development of food processing sector in the country. The scheme aims to achieve the objective by providing incentives for creation of food processing & preservation infrastructure industries in the country. The PMKSY has several on-going component schemes such as Agro Processing Cluster (APC), Integrated Cold Chain and Value Addition Infrastructure (ICC), Creation / Expansion of Food Processing & Preservation Capacities (CEPPC) and Operation Greens (OG) to provide financial assistance for setting up of Food Processing Industries (FPI) in the country. The scheme is demand driven in nature, the proposals under the scheme are invited through Expression of Interest (EOI) for setting up food processing units from all over India including state of Maharashtra. The financial assistance is provided at the rate of 35% of the eligible project cost for projects in General Areas, and 50% for projects in Difficult Areas, as well as for projects involving SC/ST, FPOs (Farmer Producer Organizations), and SHGs (Self-Help Groups). Under Operation Greens scheme, the Ministry has identified Ratnagiri, Sindhudurg and Raigad districts of Maharashtra as production clusters for Mango.

(b). Under Pradhan Mantri Formalisation of Micro food processing Enterprises (PMFME) Scheme, Mango has been identified as One District One Product (ODOP) for Ratnagiri and Sindhudurg district of Maharashtra. For the districts of Ratnagiri & Sindhudurg, 35 and 16

loans have been sanctioned respectively in Mango based products (ODOP). Marine products are identified as ODOP for Raigad district for which 16 loans have been sanctioned.

(c). The details of the progress made in infrastructure creation, marketing and branding under PMFME Scheme till 31st October, 2024 is at **ANNEXURE I**.

(d). PLISFPI is targeted to facilitate expansion of food processing capacity by creating champion brands in Food Processing Sector with total outlay of Rs. 10,900 crores for a period of 6 years (2021-22 to 2026-27). Under PLISFPI, incentives are extended to food manufacturing entities with stipulated minimum "sales" and who are willing to make stipulated "investment" for expansion of processing capacity and "branding" abroad. The details of the progress made in infrastructure creation, marketing and branding under PMFME Scheme (till 31st October 2024)

- **Credit Linked Subsidy:** 1,08,580 loans have been sanctioned and 85,532 loans disbursed.
- **Seed capital:** Amount of Rs. 1032.31 Cr. has been sanctioned for 3,10,121 Self-Help Group (SHG) members.
- **Capacity Building:** 672 Master Trainers, 1120 District Level Trainers and 87,477 Beneficiaries have been trained under the scheme
- **Incubation Centre:** 76 Incubation Centers approved with grant in aid of Rs. 206.94 Cr. Out of this, 15 Incubation Centres commissioned.
- **Marketing & Branding:** Overall 17 brands have been launched under the scheme. 15 State proposals for marketing & branding have been approved which include Aasna (Punjab), Bhimthadi (Maharashtra), Seemi (Karnataka), Bhima Pulses (Karnataka), Madugula Halwa (Andhra Pradesh), Aamodam (Andhra Pradesh), Jeevika (Bihar), Umed (Maharashtra), Temi Tea (Sikkim), Pudhugai (Tamil Nadu) and Neithal (Puducherry), India Coffee (Karnataka), Just Pure (Haryana), Govan (Goa), Sikkim Supreme (Sikkim). 2 National tie-up with NAFED done.
