Will the Minister of **FOOD PROCESSING INDUSTRIES** be pleased to state:

- (a) whether Government has implemented a Centrally Sponsored Scheme, namely Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) with an approach of 'One District, One Product (ODOP)' and if so, the details thereof;
- (b) the number of Food Processing Units set up in the country so far under said scheme, State-wise, particularly in Karnataka;
- (c) the number of Food Processing Units set up for SC/ST/OBC communities in the country, State-wise, particularly in Karnataka; and
- (d) the details of Food Processing Units functioning at present along with the employment generated by them in the country, State-wise, particularly in Karnataka?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES
(SHRI RAVNEET SINGH)

(a). Yes, Sir. Ministry of Food Processing Industries (MoFPI) is implementing a Centrally Sponsored- "Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) Scheme" for providing financial, technical and business support for upgradation of micro food processing enterprises in the country. The scheme is operational from 2020-21 to 2025-26 with an outlay of Rs. 10,000 Crore. The scheme aims to enhance the competitiveness of existing individual micro-enterprises in the unorganized segment of the food processing industry and promote formalization of the sector. The details of financial assistance offered to the prospective entrepreneurs along with eligible entities under PMFME Scheme are at **ANNEXURE-I**. The Scheme adopts One District One Product (ODOP) approach to reap the benefit of scale in terms of procurement of inputs, availing common services and marketing of products. ODOP for the scheme provides the framework for value chain development and alignment of support infrastructure. The States/UTs have identified ODOP based on the agriculture production, raw material availability, perishability of the product, presence of micro enterprises, number of Self-Help Groups (SHG) and Farmer Producer Organizations (FPO) engaged in the processing of this product. The ODOP list recommended by States/ UTs was reconciled with the list of ODOP of Ministry of Agriculture for agriculture-produce of different districts. Ministry has approved One District One Product (ODOP) for 726 districts of 35 States/ UTs.

(b) to (d). Under the PMFME Scheme, loans for 1,08,580 micro food processing units have been sanctioned through Credit Linked Subsidy support including 9,298 SC, 5,201 ST, and 56,540 OBC beneficiaries and about 3,78,004 direct / indirect employment has been generated till 31st October 2024. For the State of Karnataka, Credit Linked Subsidy for 5,177 micro food processing enterprises have been sanctioned including 375 SC, 189 ST, and 2,351 OBC beneficiaries and about 21,852 direct/ indirect employment has been generated. The State-wise details, including for the State of Karnataka, is at **ANNEXURE-II (A)**. Under the “Creation/Expansion of Food Processing and Preservation Capacities (CEFPPC) Scheme”, “Agro Processing Cluster Scheme (APC)” and “Mega Food Park Scheme (MFP)”, the umbrella scheme of “**Pradhan Mantri Kisan SAMPADA Yojana**” of this Ministry, the desired information, till 31st October 2024, is as under:

- “Creation/Expansion of Food Processing and Preservation Capacities (CEFPPC) Scheme”:- 279 projects approved, including 18 SC/ 1 ST beneficiaries, and about 26,968 direct/ indirect employment generated. For the State of Karnataka, 14 projects approved including 3 SC/ 0 ST beneficiaries, and about 1679 direct/ indirect employment generated. The State-wise details, including the State of Karnataka, are at **ANNEXURE-II (B)**.
- “Agro Processing Cluster Scheme”:- 76 projects approved including 7 SC/ 1 ST beneficiaries, and about 81,194 direct/ indirect employment generated. For the State of Karnataka, 3 projects approved and about 3050 direct/ indirect employment generated. The State-wise details are at **ANNEXURE-II (C)**.
- “Mega Food Park Scheme”:- 41 projects approved and about 97,493 direct/ indirect employment generated. For the State of Karnataka, 2 projects approved with about 5620 direct/ indirect employment generated. The State-wise details, including the State of Karnataka, are at **ANNEXURE-II (D)**.

The details of financial assistance offered to the enterprises under Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) Scheme are as under:

- (i). *Support to Individual / Group Category Micro Enterprises:* Credit-linked capital subsidy @35% of the eligible project cost, maximum ceiling Rs.10 lakh per unit;
- (ii). *Support to SHGs for seed capital:* Seed capital @ Rs. 40,000/- per member of SHG engaged in food processing for working capital and purchase of small tools subject to maximum of Rs. 4 lakh per SHG Federation.
- (iii). *Support for Common Infrastructure:* Credit linked capital subsidy @35% subject to maximum of Rs. 3 crore to support FPOs, SHGs, Cooperatives and any Government agency for setting up of common infrastructure. The common infrastructure will also be available for other units and public to utilize on hiring basis for substantial part of the capacity.
- (iv). *Branding and Marketing Support:* Grant upto 50% for Branding and Marketing to groups of FPOs/ SHGs/ Cooperatives or an SPV of micro food processing enterprises.
- (v). *Capacity Building:* The scheme envisages training for Entrepreneurship Development Skilling (EDP+): program modified to meet the requirement of food processing industry and product specific skilling.
