**FEATURES AND IMPLEMENTATION OF SELF HELP GROUPS**

2217 DR. DHARMASTHALA VEERENDRA HEGGADE:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the main features of Self Help Groups (SHGs) Scheme alongwith present status of itsimplementation in the country;
- (b) the details of SHGs in Karnataka including Dakshina Kannada district, district-wise,village-wise;
- (c) the details of funds granted, allocated, released and utilised under DeendayalAntyodaya Yojana-National Rural Livelihood Mission (DAY-NRLM) since 2019 till date,State/UT-wise;
- (d) the details of beneficiaries including women and persons belonging to SCs and STs whohave been benefited under the scheme in Karnataka, district-wise; and
- (e) the States in which transaction based monitoring system has been introduced forevaluating work done by SHGs?

**ANSWER**

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT

(a): Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY – NRLM) is implemented across the country (except Delhi & Chandigarh) with the objective of organizing the rural poor women into Self Help Groups (SHGs) and continuously nurturing and supporting them till they attain appreciable increase in incomes over a period of time and improve their quality of life and come out of abject poverty. The Mission seeks to achieve its objective through investing in four key features viz., (a) social mobilization and promotion and strengthening of self-managed and financially sustainable community institutions of the rural poor; (b) financial inclusion of the rural poor; (c) sustainable livelihoods; and (d) social inclusion, social development and convergence.

As on October 2024, the Mission is implemented in 7138 blocks in 742 districts across 28 States and 6 UTs. Cumulatively, 10.05 crore women have been mobilized into 90.87 lakh SHGs. A total amount of Capitalisation Support (Revolving Funds and Community Investment Funds) is Rs. 47,685.12 crore, and total loan disbursed is Rs. 9,60,772.49 crore, under DAY-NRLM till Oct. 2024 .

(b) to (d): A total of 3,60,684 Self Help Groups (SHGs) have been mobilised in Karnataka under Deendayal Antyodaya Yojana–National Rural Livelihoods Mission (DAY-NRLM) and 9,115 SHGs have been mobilised in Dakshina Kannada District of Karnataka, till October 2024, district-wise information is given at Annexure-I. Details on progress of DAY-NRLM including village-wise information on SHGs mobilised in Karnataka under DAY-NRLM are available on the portal at <https://nrlm.gov.in>.

The State/UT-wise details on Central allocation, Central releases and expenditure under NRLM from the year 2019-20 are provided at Annexure -II.

The district-wise details of beneficiaries including women and persons belonging to Scheduled Castes and Scheduled Tribes, who have been benefitted under DAY-NRLM in the State of Karnataka, are given at Annexure-I.
