(d): Currently, honorarium of Rs.4,500/- per month is provided to AWWs and Rs.2,250/- per month to AWHs at main AWCs; honorarium of Rs.3,500/- per month is provided to AWWs at mini AWCs. Honorarium is released on the cost sharing basis between the Central and the State

Governments & UTs which is as under:

States and UTs with Legislature - 60:40

North-Eastern and Himalayan States (including J&K) - 90: 10

UTs without legislature- 100:0

Besides, performance linked incentive of Rs.250/- per month is provided to AWHs and Rs.500/- provided to AWWs.

(e) & (f): Poshan Bhi Padhai Bhi initiative of Saksham Anganwadi and Poshan 2.0 was launched on 10th May 2023 to bring focus of the Anganwadi system on early childhood care and education and transform the Anganwadi Centre into a Learning Centre having quality infrastructure, play equipment, and well-trained Anganwadi Workers to stimulate the creative, social, emotional and cognitive development of children under 6 years of age including divyang children.

A Two Tier Implementation Model is being followed throughout the Country for Training functionaries under the scheme i.e State Level Master Trainers and Anganwadi Workers. Poshan Bhi Padhai Bhi Training covers all Anganwadi functionaries once in Year 1 and Year 2 as a basic ECCE and Nutrition training, i.e. Round 1, and then once again in Year 3 for more expensive training, i.e. Round 2.

(g) & (h): 'Salary Component' for States (Excepting NER and Himalayan States) was discontinued from the F.Y. 2023-24 and the 'savings' accrued from this have been given for other components like Training Components under Poshan Bhi Padhai Bhi, Smartphones and data support, enhanced support for Pre School Education (PSE) kit etc.
