Will the Minister of STATISTICS AND PROGRAMME IMPLEMENTATION be pleased to state:

- (a) the details of the approved projects in Railways, Highways, Jal Shakti, Rural Development and Urban Development to be implemented in the State of Karnataka and funds earmarked for the same, during the last two years; and
- (b) the details of approved projects to be implemented in the State of Karnataka, across Ministries, which are stuck with the State Government, during the above said period?

- (a) The Ministry of Statistics and Programme Implementation is mandated to monitor Ongoing Central Sector Infrastructure Projects costing ₹ 150 crore and above on time and cost overrun, based on the information reported by the Line Ministries/ Project Implementing Agencies on the Online Computerized Monitoring System (OCMS) of this Ministry. As on 01.11.2024, there exist total 1747 projects on the monitor of this ministry which includes 82 projects in state of Karnataka. The detail of these projects is available at www.cspm.gov.in.

The number of projects in the State of Karnataka along with its Original and Anticipated cost as implemented by M/o Railways, M/o Road Transport & Highways and M/o Urban Development is at **Annexure-I**.
