Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) the number of people registered as beneficiaries of Public Distribution System (PDS) in the country, State-wise, year-wise for the last five years;
- (b) the amount of money spent on each PDS for each State by the Union Government, year-wise, State-wise and scheme-wise for the last five years; and
- (c) the number of people who have been removed or opted out of PDS in the last five years, State-wise and year-wise?

(a): The PDS is now governed as per the provisions of The National Food Security Act, 2013. The Act provides for coverage of 75% of the rural and 50% of the urban population, which at Census, 2011 population comes out to around 81.35 crore persons. A statement indicating the State/UT-wise number of beneficiaries covered under the Act during the last 5 years is at **Annexure I**.

(b): The Government of India does not allocate State-wise funds under Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) rather funds towards food subsidies are released to the Food Corporation of India (FCI) and States that have adopted Decentralized Procurement based on the distribution of food grains to the targeted beneficiaries.

The details of food subsidies released to FCI & DCP States for the last 5 years are in **Annexure II**.

In addition, funds are also released to States/UTs under the centrally sponsored scheme "Assistance to state agencies for intra-state movement of foodgrains & FPS Dealers margin under NFSA" for meeting the expenditure incurred by States/UTs for meeting expenditure on intra-state movement and handling of foodgrains and Fair Price Shop (FPS) dealers' margin for foodgrains distributed to beneficiaries under the Act. The details of funds released to States/UTs during the last 5 years are in **Annexure III**.

(c): As an outcome of the use of technology in TPDS operations i.e., digitization of ration cards/beneficiary databases, Aadhaar seeding, de-duplication process, identification of duplicates, ineligible records, deaths, permanent migration of beneficiaries, etc. all States/UTs have been able to weed-out ineligible ration cards in order to achieve rightful targeting. A statement showing the State-wise, and year-wise number of deleted ration cards is in **Annexure IV**.
