**SALIENT FEATURES OF e-SHRAM PORTAL**

**1209. # DR. SUMER SINGH SOLANKI:**

**Will the Minister of Labour and Employment be pleased to state:**

- (a) the salient features of the e-Shram portal;**
- (b) the extent to which it would benefit unorganized workers; and**
- (c) whether it has been implemented across the country, if so, the details thereof?**

**ANSWER**

**(a) to (c):** The Ministry of Labour and Employment launched eShram portal ([eshram.gov.in](http://eshram.gov.in)) on 26<sup>th</sup> August 2021 for creation of a comprehensive National Database of Unorganised Workers (NDUW) verified and seeded with Aadhaar. eShram portal is meant to register and support the unorganised workers by providing them a Universal Account Number (UAN) on a self-declaration basis. As on 1<sup>st</sup> December 2024, over 30.43 crore unorganised workers have registered on eShram portal. The details of States/UTs wise count of unorganised workers registered on eShram portal are annexed.

**The salient features of the eShram portal and benefits to unorganised workers are as below:**

- i. eShram has been integrated with National Career Service (NCS) portal. An unorganised worker can register on NCS using his/her Universal Account Number (UAN) and search for suitable job opportunities. An option/ link has also been provided to registrants' on eShram portal to seamlessly register on NCS.**
- ii. eShram is integrated with Pradhan Mantri Shram Yogi Maandhan (PM-SYM). PM-SYM is a pension scheme for unorganised workers who are aged between 18-40 years. It provides a monthly pension of Rs. 3000/- after attaining the age of 60 years. Using UAN any unorganised worker can easily enrol under PM-SYM. In the scheme 50 percent of the contribution is borne by the Government of India and the rest is being contributed by the worker.**

- iii. **Provision has been added in eShram to capture family details of migrant workers.**
- iv. **Provision has been added in eShram to share construction workers' data with States/ Union Territories to facilitate their registration in respective Building and other Construction Workers (BoCW) boards.**
- v. **To provide skill enhancement and apprenticeship opportunities to unorganised worker, eShram has been integrated with Skill India Digital portal of Ministry of Skill Development and Entrepreneurship.**
- vi. **eShram is also integrated with myScheme portal. myScheme is a National Platform that aims to offer one-stop search and discovery of the Government schemes. It provides an innovative, technology-based solution to discover scheme information based upon the eligibility of the citizen.**

**In keeping with the vision of the Budget Announcement recently on developing eShram as a One-Stop-Solution for unorganised labour to have access to various social sector schemes, Ministry of Labour and Employment launched the eShram-“One-Stop-Solution” on 21st October 2024. eShram- “One-Stop-Solution” entails integration of different Social Security/ Welfare schemes at single portal i.e. eShram. This enables unorganised workers registered on eShram to access social security schemes and see benefits availed by them so far, through eShram.**

**So far, 12 schemes of different Central Ministries / Departments have already been integrated/ mapped with the eShram including Pradhan Mantri Surakhsa Bima Yojana (PMSBY), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana, Prime Minister Street Vendors AtmaNirbhar Nidhi (PM-SVANidhi), PM Awas Yojana- Urban (PMAY-U), PM Awas Yojana- Gramin (PMAY-G), Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA).**
